State Center City Council Regular Meeting Minutes August 17, 2019

State Center City Council met in regular session on Wednesday, August 21, 2019 in the City Hall Council Room. Mayor Sodders called the meeting to order and asked everyone to rise for the Pledge of Allegiance. Roll Call: Mayor Sodders, Councilors: Darrow, Nichols, and Wilkinson. Absent: Bunn and Shaffar. Others Present: Kevin O'Hare, Zach Faught, Mike Kielly, Linda Wells, Brad Pfantz, Chris Davis, Matt & Jennifer Jensen, Jacob Weuve, Doug & Julie Riley, Katherine Dickey and Lori Bearden.

- Motion by Darrow, 2nd by Nichols to approve the consent agenda including payment of \$120,000.00 for street sweeper approved last month and liquor license for Hometown Foods. Motion passes 3-0.
- The City has received an offer to buy Figgins 2 Lot 6, locally known as 409 3rd St SE from Matt & Jennifer Jensen. At 7:02, Pursuant to Iowa Code 21.5(1)j: To discuss the purchase or sale of particular real estate only where premature disclosure could be reasonably expected to increase the price the governmental body would have to pay for that property or **reduce the price the governmental body** would receive for that property, motion by Wilkinson, 2nd by Nichols to enter closed session for discussion on the offer received and asked that Atty. O'Hare and Mike Kielly attend. Motion passes 3-0.
- At 7:07, motion by Wilkinson, 2nd by Darrow to re-enter open session. Motion passes. All attendees listed above re-entered. The Jensen's were informed that there was some legal research that would need to be done before the council could further consider their offer and the offer would be put on the September 18th meeting agenda.
- At 7:08, motion by Wilkinson, 2nd by Darrow pursuant to Iowa Code 21.5(1)j: To discuss the purchase or sale of particular real estate only where premature disclosure could be reasonably expected to **increase the price the governmental body would have to pay for that property** or reduce the price the governmental body would receive for that property, to enter closed session for discussion on the price of property being considered for a future fire station and asked that Atty. O'Hare, Mike Kielly and Brad Pfantz attend. Motion passes 3-0.
- At 7:23, motion by Darrow, 2nd by Nichols to re-enter open session. All attendees listed above re-entered the meeting except Matt & Jennifer Jensen. No action will be taken by council at this time, Brad and Mike Kielly will continue to consider location options. Brad Pfantz left at this time.
- There was not any discussion specific to Electric or Public Works.
- Mayor Sodders reported that there is almost 30 days left for Police Chief applications to come in. If no acceptable candidates applied the City could hire a job search company. Other communities have had some success with this route.
- Mayor Sodders reported that Dain Winterton has passed all testing with high results. He, Mike Kielly and Dan Quigley conducted an interview with Dain. He feels Dain would be a good fit for the community and asked for approval to offer Dain a part-time position at no more than \$25.00/hour until January when he would become a full-time Officer and start law enforcement academy. He would be subject to a contract requiring a scaled pay back of academy costs if he left the position before 4 years of city employment. Currently our 6 part-time officers are paid \$25.00/hour while we are without our two full-time officers, this rate will go back to normal rates once the full-time positions are filled. It was noted that law enforcement coverage has been excellent with the part-time officers scheduling themselves and the Sheriff's office taking dispatch calls for us.
- Due to recent amount of excessive noise/commotion in the city, it was discussed that language could be added to our code to curtail some of this. The clerk will look to other communities for examples.
- Katherine Dickey spoke to the council regarding 4th of July firework damage to her home. She is working with insurance companies to take care of the damage. She is very concerned about the

- size and number of fireworks that were being used; the incident could have easily resulted in a home on fire or severe injuries to those involved including young children. The Clerk will look for examples from other communities as the council indicated favor for making the community safe for all.
- Motion by Wilkinson, 2nd by Nichols to hold Halloween Beggar's Night on Thursday, October 31st from 5 to 7 p.m. Motion passes 3-0. Julie Riley spoke to the council about blocking off Main St. for the Trunk or Treat the SCDA plans for that evening. The clerk will inform the police department of Halloween plans so that coverage can be arranged. Julie also shared that Watson's Fall Festival is scheduled Friday, Sept. 27th and Christmas on Main will be Friday, Dec. 6th.
- Darrow moved that Ordinance 348, amending council compensation to an annual payment of \$700.00 per council member be given its second reading for passage. Nichols 2nd; motion passes 3-0 roll call vote.
- Motion by Darrow, 2nd by Nichols approving Figgins 3 lot address numbers as submitted and on file with the clerk's office. Motion passes 3-0 roll call. The address numbers will be sent to the county.
- After explanations by the clerk regarding an adjustment to one of the report's beginning balances, Wilkinson introduced and moved to adopt Res. 20-01approving the FY19 Street Finance Report as presented. 2nd by Darrow, Res. 20-01 is adopted 3-0 roll call.
- The clerk shared that she and the billing clerk are evaluating the current electric and water utility deposit amounts. They feel these need to be updated to better protect the City from billing losses. They will present options at the September council meeting.
- Wilkinson introduced and moved to adopt Res. 20-02 accepting the petition submitted requesting that the question "Shall the term of mayor for City of State Center be changed from 2 years to 4 years effective with term beginning January 1, 2022?" be added to the November 5th, 2019 election ballot. Nichols 2nd, Res. 20-02 is adopted 3-0 roll call. This would have to pass at the election with a simple majority of voters and cannot take effect until after the next City election in 2021. A mayor candidate on the ballot this 2019 election would only serve 2 years.
- There being no further business, motion by Wilkinson, 2nd by Darrow to adjourn at 8:12 p.m. Motion passes 3-0.
