

State Center City Council
 Regular Meeting Minutes
 January 16, 2023
 State Center City Hall

Mayor Pfantz opened the council meeting at 6:30 p.m. Present were Quick, Darrow, Grant, Nichols, and Shaffar. Absent: None. Also, present were L. Bearden, T. Hillers, K. Yates, J. Thomas, P. Pitzen, M. Kielly, C. Davis, N Fredriksen and C.J. Gross.

There were no comments made during the public comment period.

Motion by Quick, 2nd by Darrow approving the consent agenda including Res. 24-36 monthly fund transfers totaling \$108,307.43. Motion passes 5-0 roll call.

Motion by Darrow to adopt Res. 24-37 approving of Pay Application #14 to WRH for work on R/O project in amount of \$153,292.37. Grant 2nd; Res. 24-37 is adopted 5-0 roll call. Fredriksen with ISG reviewed progress of R/O water treatment plant. Progress is on schedule. Fredriksen and Gross then presenting finance options for the lift station/sewer lagoon project. Another grant has surfaced that could provide \$500,000.00 for each of the two components of this project. The WTFAP grant has a November application deadline with early 2025 award. C.J. will work on the qualifications. Financing options still appear to be most advantageous if the whole project continues to be split into two components, the lift station, and the treatment/lagoon.

Public works has been most recently buried with snow removal.

Vacant building ordinance will be drafted by the police chief and city attorney.

Chief Pfantz stated that the architect for the fire station project will be soon meeting with himself, T. Shaffar, and M. Kielly to consider current station and Opera/Masonic building to the east renovations for Fire/EMS. The joint Township/City/Fire.EMS meeting is postponed from Jan. 13 to Jan 20 due to weather.

Ordinance 381 amending Chapter 50, Nuisances of the City Code was reviewed. The ordinance will be presented for a 1st reading at the next meeting, possibly Jan. 26.

Property valuations have not been filed for Marshall County yet so there was no further budget discussion. A budget meeting is now scheduled for Jan. 26, 5:30 p.m.

Motion by Quick, 2nd by Grant approving a budgeted payment to SCDA in amount of \$5,000.00 for support of the association's director salary. Motion passes 5-0.

At 7:15, there being no further business, motion by Darrow, 2nd by Quick to adjourn meeting. Motion passes 5-0.


